Registration will be free for 1950 and older stock vehicles. **ALL SHOW VEHICLES MUST BE ON THE PROPERTY NO LATER THAN 9:30AM.** This is to ensure safety to all.

GENERAL INFORMATION

- Cars not in the show will park across Montauk Highway at Gardiner County Park.
- All show vehicles and vendors must arrive between 8 am and 9:30 am. (Enter West Gate no earlier than 8 am)
- All vehicles must be driven through registration and onto the show field under their own power.
- All vehicles must be insured and registered.
- No packing or leaving the show before 3:00 pm.
